Florida Teachers of Tomorrow Enrollment Deferral

Defer \$150 of enrollment fee when enrolled

Enrollment Deferral offers will be extended to potential candidates who are not yet enrolled with Florida Teachers of Tomorrow, as of July 1, 2020, and who already hold a valid Florida Temporary Certificate. Any candidate who currently holds a valid Florida Temporary Certificate, and enrolls between July 1, 2020 - December 31, 2020, is eligible to enroll for \$95 and defer the remaining \$150, which is due, in full, upon obtaining employment. Once enrolled, the candidate is deemed an "enrollee." The enrollment deferral will be applied within 60+ days of the enrollment date. The submission is up to 1 person per lifetime and will be released by Florida Teachers of Tomorrow throughout the United States.

Official Rules

NO PURCHASE NECESSARY TO BE AWARDED ENROLLMENT DEFERRAL. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF BEING AWARDED. VOID WHERE PROHIBITED. THIS ENROLLMENT DEFERRAL AWARD IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH OTHER PROGRAMS.

1. ENROLLMENT DEFERRAL DESCRIPTION:

The "Florida Teachers of Tomorrow Enrollment Deferral" ("Enrollment Deferral of \$150") offers applicants the ability to enroll in the Florida Teachers of Tomorrow Program with a reduced enrollment fee of \$95 at the time of enrollment, granted they hold a valid Florida Temporary Certificate and meet all other program admission requirements. The total fee to be paid at the time of enrollment at the deferred price is \$95; the remaining \$150 enrollment fee will be automatically added to the remaining program balance. After the enrollment of the enrollee, a verification period of a panel of judges will determine the enrollee's acceptance of the eligible submission (as described in more detail below). Up to 1 Enrollment Deferral will be awarded and cannot be claimed in conjunction with any other Florida Teachers of Tomorrow offer, special or discount, per the criteria, as defined below.

The Enrollment Deferral will flow as follows:

- **Enrollment Period**: The ENROLLMENT DEFERRAL Period begins from July 1, 2020, at 12:00:01 a.m. Eastern Time (ET) and ends on December 31, 2020, at 11:59:59 p.m. ET.
- **Verification Period**: The ENROLLMENT DEFERRAL review period will start 24-48 hours after enrollee is deemed eligible for program admission by a Florida Program Advisor.
- Enrollment Deferral Awarded Announcement: The enrollment deferral will be confirmed after a verification period of 30+ days. The \$150 enrollment deferral is automatically added to the remaining program fee/s.

By participating in this enrollment deferral, each enrollee unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsors, which shall be final and binding in all respects. All federal, state, and local laws and regulations apply. The sponsor's computer is the official timekeeping device for this award.

2. ELIGIBILITY:

Enrollment deferral is open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. You MUST already hold a valid Florida Temporary Certificate. You are NOT eligible if you are already enrolled in any of the Florida Teachers of Tomorrow certification program.

3. HOW TO ENTER / SUBMISSION REQUIREMENTS:

All eligible enrollees will speak with a Program Advisor once they have applied. If eligible and accepted into the Florida Teachers of Tomorrow program, the Enrollment Deferral of \$150 will manually be applied, by the Program Advisor, to the enrollee's account. The enrollee must submit the enrollment fee to avail of the discount. By taking these steps, an enrollee will receive one (1) entry. Each Submission must meet the following "Submission Requirements" (and any Submission that, in the Sponsor's sole and absolute discretion, violates the following criteria will be disqualified):

- Must not already be enrolled with Florida Teachers of Tomorrow
- Must not already be enrolled with any Educator Preparation Program
- Must submit application on Florida Teachers of Tomorrow
- Must submit application before December 31, 2020
- Must meet Florida Teachers of Tomorrow Admission Requirements
- Submissions must NOT contain material which is (or promoting activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking, substance abuse, computer hacking, etc.), offensive, inappropriate, threatening, profane, or harassing; or material that contains any derogatory references to any Enrollment Deferral (as defined below);
- Submissions must be entirely original to the participant;
- Submissions must NOT have been previously submitted to another Enrollment Deferral
 offer or submitted to any entity that would conflict with this Enrollment Deferral, as
 determined in the Sponsor's sole discretion;
- Submissions must NOT include third parties/people, who have not expressly authorized
 the entrant to display their image or likeness in the Submission for purposes of this
 Enrollment Deferral. Third Parties include but are not limited to celebrities, friends, and
 minors who have not obtained parental consent prior to such participation;
- Submissions must NOT contain any personally identifiable information of the entrant unless required (e.g. reasons why the need the Enrollment Deferral,);
- Must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright, trademark or patent infringement; and
- Must not contain brand names or trademarks other than those owned by Sponsor, which entrants have a limited license to use to incorporate in entrant's Submission.

Limit one (1) submissions per person, regardless of method of submission Any attempt by any submission to obtain more than one (1) submission per person by using multiple/different e-

mail addresses, identities or any other methods will void that entrant's entries and that entrant will be disqualified. Submissions will not be returned or acknowledged.

4. VERIFICATION PERIOD:

During the Verification Period, the Sponsor will review all Submissions to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements set forth in these Official Rules shall result in a voided submission via a Sponsor's sole discretion.

5. AWARDED ENROLLMENT DEFERRAL SELECTION:

(A) 2020 Florida Teachers of Tomorrow ENROLLMENT DEFERRAL: At the close of the **VERIFICATION PERIOD**, the Submission will be reviewed by judges based on the completion of requirements. The potential enrollee will be notified by direct message to the email the submission used to submit the Submission entry. The potential enrollee must submit enrollment payment by December 31, 2020; after the time of notice or else that potential Enrollment Deferral may be disqualified and voided. The potential enrollee may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Florida Teachers of Tomorrow ENROLLMENT DEFERRAL Entities (the "Enrollment Deferral Claim Documents"), within a reasonable amount of time, as determined by the Sponsors, in their sole discretion. The potential award will not be eligible to receive an Enrollment Deferral until all properly completed Enrollment Deferral Submission Documents are received.

Florida Teachers of Tomorrow shall have no liability for any winner notification that is lost, intercepted or not received by a potential awardee for any reason. If any potential awardee (i) does not respond within the time required by Sponsor (including, without limitation, if the winner notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such a potential winner will forfeit his or her prize and an alternate winner may be selected based on the selection process outlined in this section.

6. GRANT OF RIGHTS:

By submitting a submission, each enrollee agrees that the submission is gratuitous and made without restriction, that it will not place Sponsors under any obligation other than as stated in these Official Rules, that a Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a Submission, a Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant. Each enrollee into the program hereby irrevocably grants to Sponsors, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully-paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity

and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Enrollment Deferral and other promotions. Sponsors shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate or alter the Submission for any purpose which Sponsors deem necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. Entrants further agree: (i) that the Enrollment Deferral Entities may exercise any and all rights hereunder without notification or compensation (except for any prize to be deferred enrollment hereunder); (ii) that the Enrollment Deferral Entities shall have the right to freely assign their rights hereunder, in whole or in part, to any other person or entity, without notification or approval by entrants; (iii) Sponsor shall have no obligation (express or implied) to use any submission or to otherwise exploit any Submission or, if commenced, to continue the distribution or exploitation thereof, and Sponsor may at any time abandon the use of the submission for any reason, with or without legal justification or excuse, and entrants shall not be entitled to any damages or other relief by reason thereof; and (iv) to sign and deliver to the Enrollment Deferral Entities such documents as the Enrollment Deferral Entities may reasonably require to effectuate the rights granted herein. Sponsors shall not incur any liability whatsoever to the extent Sponsors choose to refrain from any exploitation of rights hereunder.

7. ENROLLMENT DEFERRAL AND APPROXIMATE RETAIL VALUES:

(A) Enrollment Deferral Awardee / Enrollment Deferral Winner containing:

The enrollee will receive one Enrollment Deferral for Florida Teachers of Tomorrow for the value of \$150. They must complete the Florida Teachers of Tomorrow program and receive a valid Professional or Emergency Certificate by **December 31, 2024,** or the Enrollment Deferral becomes **void**. Enrollment Deferral will become **void** if the submission was not submitted before December 31, 2020. Florida Teachers of Tomorrow Enrollment Deferral will be **voided** if the awarded enrollee is officially discharged/dropped by Florida Teachers of Tomorrow. The Enrollment Deferral only includes a \$150 deferred payment of the enrollment fee. It will be transferred to the remaining program financial balance. The Enrollment Deferral does not include any or all required State Exams, background checks, fingerprinting services, additional certification requirements, or any additional fees noted on the website. No additional or current Enrollment Deferral funds will be transferred to additional resources.

8. GENERAL: By participating in the Enrollment Deferral, each enrollee agrees to release and hold harmless the Sponsors, and their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, prize suppliers, and each of their respective officers, directors, employees, and agents, and any other person or entity involved in the production, development, implementation or handling of the Enrollment Deferral (collectively, the "Enrollment Deferral Entities") from and against any claim or cause of action, to the fullest extent permissible by law, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Enrollment Deferral, or receipt or use or misuse of any Enrollment Deferral. Entrants further agree that the Enrollment Deferral Entities have not made any warranty, representation or guarantee express or implied, in fact, or law, with respect to the Enrollment Deferral(s), including, without limitation, to such prize's quality or fitness for a particular purpose. Sponsor assumes no responsibility for any damage to

an entrant's computer system which is occasioned by participating in the Enrollment Deferral, or for any computer system, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions or network connections that are human or technical in nature. Without limiting the generality of the foregoing, the Deferral Entities are not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, or stolen entries, or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or the incorrect or inaccurate capture of information, or the failure to capture any information. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Deferral, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Enrollment Deferral, or to annoy, abuse, threaten or harass any other person, and Sponsors reserve the right to seek damages and other remedies from any such person to the fullest extent permitted by law. In the event that an insufficient number of eligible Submissions are received, or a Sponsor is prevented from continuing with the Enrollment Deferral, as contemplated herein by any event beyond its control, Sponsors shall have the right to modify, suspend, or terminate the Enrollment Deferral, If the Enrollment Deferral, is terminated for any reason before the designated end date, Sponsors will (if possible) select the potential winner from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If, by reason of a print or other error, more awards are claimed than the number set forth in these Official Rules, a winner will be selected in accordance with the winner selection method described above from among all eligible claimants making purportedly valid claims to Enrollment Deferral the advertised number of awards available.
