

Teachers of Tomorrow Get Ready Discount

Discount Eligibility Requirements for Indiana

Submissions will be accepted from April 1, 2020 – May 1, 2020 for the selection of awarded discounts and will be applied within 30+ days of the application date. The submission is up to 1 person per lifetime and will be released by Teachers of Tomorrow throughout the United States.

Official Rules

NO PURCHASE NECESSARY TO BE AWARDED DISCOUNTS. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF BEING AWARDED. VOID WHERE PROHIBITED. THIS DISCOUNT AWARD IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH OTHER PROGRAMS.

1. DISCOUNT REQUIREMENTS:

The “Teachers of Tomorrow Get Ready Discount” (“Discount of \$75 OR \$150 OR \$200”) offers enrolled Indiana Teachers of Tomorrow candidates the ability to earn a discount to be applied to total program fee. After the submission, Teachers of Tomorrow will review submissions. Up to 1 discount will be awarded in accordance with meeting the criteria as defined below.

The discount award will flow as follows:

- **Submission Period:** The “Teachers of Tomorrow Get Ready Campaign Discount” begins from April 1, 2020 at 12:00:01 a.m. Central Time (“CT”) and ends from May 1, 2020, at 11:59:59 p.m. CT.
- **Verification Period:** The review period will start 15-90 days after submission of completion form.
- **Discount Awarded Announcement:** The announcement of the discount will take place around 30+ days after a verification period.

By participating in this discount, each candidate unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsors, which shall be final and binding in all respects. All federal, state, and local laws and regulations apply. The sponsor’s computer is the official timekeeping device for this award.

2. ELIGIBILITY:

Discount submission is open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. You are ONLY eligible if you are already enrolled into the Teachers of Tomorrow certification / licensing program and have not completed your YSP or YSP and Classroom Readiness Training

3. HOW TO ENTER / SUBMISSION REQUIREMENTS:

The candidate is eligible for either a \$75, \$150 OR \$200 program fee discount. Candidates must compete ALL requirements associated with each discount to receive said discount.
Discounts

are structured on a tier model and are NOT independent of one another. To receive a Tier One (T1) Discount valued at \$75, candidates must complete the following requirements:

- Complete Youth Suicide Prevention Training Certification*
*Certifications must be completed before May 1, 2020. A 15-calendar day window is granted to candidates for certification submission. Proof of certification attainment must be submitted by June 15, 2020, at 11:59:59 p.m. CT.

To receive a Tier Two (T2) Discount valued at \$150, candidates must complete the following requirements:

- Complete T1 requirements.
- Complete all online training modules included in their Classroom Readiness training. Candidates must submit proof before May 1. No additional discounts will be applied if candidate does not meet these requirements.

To receive a Tier Three (T3) Discount valued at \$200, candidates must complete the following requirements:

- Complete T1 requirements.
- Complete T2 requirements.
- Complete CPR/AED/Heimlich Training Certification*
*Certifications must be completed before May 1, 2020. A 15-calendar day window is granted to candidates for certification submission. Proof of certification attainment must be submitted by June 15, 2020, at 11:59:59 p.m. CT.

Proof of submission is required. Candidates must fill out a form and submit the following information:

- First Name
- Last Name
- Phone Number
- Email Address
- Date of Last Completed Modules

All submitted forms will be reviewed and verified by Teachers of Tomorrow before any discount is awarded.

Additional requirements:

- Submissions must NOT contain material which is (or promoting activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking, substance abuse, computer hacking, etc.), offensive, inappropriate, threatening, profane, or harassing; or material that contains any derogatory references to any discount (as defined below);
- Submissions must be entirely original to the participant;
- Submissions must NOT have been previously submitted to another discount or submitted to any entity that would conflict with this discount, as determined in the discount Entities' sole discretion;
- Submissions must NOT include third parties/people, who have not expressly authorized the entrant to display their image or likeness in the Submission for purposes of this

discount. Third Parties include but are not limited to celebrities, friends and minors who have not obtained parental consent prior to such participation;

- Submissions must NOT contain any personally identifiable information of the entrant unless required (e.g. reasons why the need the discount,); and

4. VERIFICATION PERIOD:

All submissions received before the deadline will be reviewed for approval by Teachers of Tomorrow within 15-90 business days. If approved, candidates will be notified by personal message to their email account.

5. AWARDED DISCOUNT SELECTION:

(A) 2020 Teachers of Tomorrow Get Ready Discount: At the close of the **VERIFICATION PERIOD**, the Submission will be reviewed by judges based on completion of requirements. Selections will be deemed as a potential discount recipient.

The potential discount will be notified by direct message to the email the submission used to submit the Submission entry. The potential discount must respond to Sponsor's notice by August 31, 2020 after the time of notice or else that potential awardee/discount may be disqualified and voided. The potential awardee may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Teachers of Tomorrow Get Ready Discount Entities (the "Discount Claim Documents"), within a reasonable amount of time, as determined by the Discount Entities in their sole discretion. The potential award will not be eligible to receive a discount until all properly completed Discount Claim Documents are received.

The Discount Entities shall have no liability for any winner notification that is lost, intercepted or not received by a potential awardee for any reason. If any potential awardee (i) does not respond within the time required by Sponsor (including, without limitation, if the winner notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such a potential winner will forfeit his or her prize and an alternate winner may be selected based on the selection process set forth in Section.

6. GRANT OF RIGHTS:

By submitting a Submission, each entrant agrees that the Submission is gratuitous and made without restriction, that it will not place Sponsors under any obligation other than as stated in these Official Rules, that a Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a

Submission, a Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant. Each entrant into the Get Ready Discount hereby irrevocably grants to Sponsors, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Discount and other promotions. Sponsors shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which Sponsors deem necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. (A) Discount Awardee / Discount Winner containing:

The candidate will receive one full discount for Teachers of Tomorrow. They must complete the Teachers of Tomorrow program / receive standard certification / License by **Aug 15, 2025** or the discount becomes **void**. Teachers of Tomorrow Discount will be **voided** if the awarded candidate is officially discharged / dropped by Teachers of Tomorrow. The discount only includes **\$100 off the program financial balance** and will be applied to the final cost. The discount does not include any additional fees noted on the website. No additional or current discount funds will be transferred to additional resources. Discount cannot be redeem for a cash value.

8. GENERAL:

In the event an insufficient number of eligible Submissions are received, or a Sponsor is prevented from discounting prize(s) or continuing with the discount, as contemplated herein by any event beyond its control, Sponsors shall have the right to modify, suspend, or terminate the discount, If the discount, is terminated for any reason before the designated end date, Sponsors will (if possible) select the potential winner from all eligible, non-suspect entries received as of the date of the event giving rise to the termination.
