\$95 Enrollment Offer after \$200 Rebate

Texas Teachers of Tomorrow \$95 Enrollment Offer after \$200 Rebate (classified as a Discounted Enrollment Fee) Overview: This offer is only available to applicants who are not enrolled in the Texas Teachers of Tomorrow Program prior to October 26, 2020. To be eligible, candidates must enroll with Texas Teachers of Tomorrow, Submit the Submission Form and complete all requirements associated with the \$95 Enrollment Offer after \$200 Rebate. Submission forms will be accepted from October 26, 2020, to December 31, 2020. Rebates will be issued to eligible candidates between November 1, 2021, and December 31, 2021.

Official Rules

The Sponsor of 2020 Teachers of Tomorrow's: \$95 Enrollment Offer after \$200 Rebate ("Enrollment Rebate") is Teachers of Tomorrow ("Sponsor"). By participating in this Enrollment Rebate, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. All federal, state, local laws, and regulations apply. The Sponsor's computer is the official timekeeping device for the Enrollment Rebate.

No purchase is necessary to enter. Purchases will not increase your chances of receiving the Enrollment Rebate. Void where prohibited. The Enrollment Rebate may not be redeemed for cash value and cannot be combined with any other discounts, rebates, giveaways, or promotions. The Enrollment Rebate is in no way sponsored, endorsed, or administered by, or associated with, other programs.

ENROLLMENT REBATE PROCEDURE: The Enrollment Rebate Procedure will flow as follows:

1. Apply to the Texas Teacher of Tomorrow program.
2. Enroll before the end of the Submission Period (see below).
3. Submit the Rebate Submission Form located on the official Texas Teachers of Tomorrow webpage before the end of the Submission Period (see below).
4. Take and pass TExES Content Exam before the end of the Claim Period (see below).
5. Secure verifiable teaching employment before the end of the Claim Period (see below).

After the submission and verification period, the Enrollment Rebate will be released in accordance with the judging criteria as defined below:

- **Submission Period:** The Submission Period opens to the public on October 26, 2020, at 12:00:01 AM Central Time ("CT") and closes on December 31, 2020, at 11:59:59 PM CT.
- **Claim Period:** The Claim Period opens to applicants who have submitted the Rebate Submission Form as soon as they have enrolled with Texas Teachers of Tomorrow and closes on October 1, 2021. During the Claim Period, candidates may work toward passing their TExES Content Exam and securing verifiable teaching employment to claim the Enrollment Rebate.
- **Verification Period:** The review period will begin 30-90 days after the Claim Period Closes.
- **Enrollment Rebate Recipients Announcement:** The announcement of the Enrollment Rebate Recipients be communicated via email between November 01, 2021 – December 31, 2021.

ELIGIBILITY: Submissions for the Enrollment Rebate are open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. Only candidates who are not enrolled in the Texas Teachers of Tomorrow program prior to October 26, 2020, will be considered for the Enrollment Rebate. Only applicants who enroll and submit the Rebate Submission Form before the Submission Period closes will be considered for the Enrollment Rebate. Additionally, only candidates who pass their TExES Content Exam and get hired before the Claim Period closes are eligible to receive the Enrollment Rebate.

HOW TO ENTER: The candidate may enter for the Enrollment Rebate by submitting the Rebate Submission Form, located on the official Texas Teachers of Tomorrow webpage. To be considered for the Enrollment Rebate, the candidate must submit the Submission Form before the Submission Period closes. Candidates who pass their TExES Content Exam and get hired before the Claim Period closes are eligible to receive the Enrollment Rebate.

NUMBER OF ENTRIES: By taking the aforementioned steps outlined in the Enrollment Rebate Procedure, each Entrant will receive one (1) entry. Candidates are only eligible to receive one (1) Enrollment Rebate. If awarded the Enrollment Rebate, the candidate is not eligible to receive any additional discounts, rebates, giveaways, or promotions.

SUBMISSION REQUIREMENTS: Each Submission must meet the following "Submission Requirements" (and any Submission that, in the Sponsor's sole and absolute discretion, violates the following criteria will be disqualified and will not be returned or acknowledge by the Sponsor):

Terminology:

- **Entrant:** *Any lead, applicant, or potential candidate who is not yet enrolled in the Texas Teachers of Tomorrow program.*
- **Candidate:** *A previous lead or applicant who has since successfully enrolled in the Texas Teachers of Tomorrow program.*
- **Participant:** *Entrants and Candidates participating in the Enrollment Rebate.*
- **Submissions:** *Enrollment Rebate Submission Form submission.*

Requirements:

- Entrant must apply to the Texas Teachers of Tomorrow program;
- Entrant must not be enrolled in the Texas Teachers of Tomorrow Program prior to October 26, 2020;
- Entrant must enroll in the Texas Teachers of Tomorrow program by December 31, 2020;
- Entrant or Candidate must submit the Rebate Submission Form, located on the Texas Teachers of Tomorrow website by December 31, 2020;
- Candidate must receive a passing score on their required TExES Content Exam for the corresponding subject area for which they were approved by Teachers of Tomorrow by October 1, 2021, to be eligible to claim the Enrollment Rebate;
- Candidate must secure verifiable teaching employment by October 1, 2021, to be eligible to claim the Enrollment Rebate;
- Submissions must be entirely original to the participant;

- Participants must not have previously submitted, or intend to submit, or another offer, reward, rebate, or giveaway, that would conflict with this Enrollment Rebate, as determined by the Sponsors' sole discretion;
 - Submissions must not include third parties/people, who have not expressly authorized the entrant to display their image or likeness in the Submission for purposes of this Enrollment Rebate. Third parties include but are not limited to celebrities, friends, and minors who have not obtained parental consent prior to such participation;
 - Submissions must not contain any personally identifiable information of the entrant unless required (e.g. reasons why they need the Enrollment Rebate.);
 - Submissions must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity, or intellectual property rights, or that constitutes copyright, trademark, or patent infringement; and
 - Submissions must not contain brand names or trademarks other than those owned by the Sponsor, which entrants have a limited license to use to incorporate in Entrant's Submission.

VERIFICATION PERIOD: During the Verification Period, the Sponsor will review all Submissions to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements outlined in these Official Rules shall result in a voided submission in the Sponsor's sole discretion. If approved, candidates will be notified by personal message to their email account.

REWARD RECIPIENT SELECTION: At the close of the Claim Period, the Submissions will be reviewed by judges based on completion of requirements and verification of passing TExES Content Exam Scores and verification of teaching employment. Selections will be deemed as a Potential Enrollment Rebate Recipient ("Potential Recipient").

The Potential Recipient will be notified by direct message to the email the Participant used to submit the Rebate Submission Form. The Potential Recipient must respond to the Sponsor's notice within forty-eight (48) hours after the time of notice, or else that Potential Recipient may be disqualified and voided.

The Potential Recipient may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Enrollment Rebate (the "Reward Claim Documents"), within a reasonable amount of time, as determined by the Sponsor in their sole discretion. The Potential Recipient will not be eligible to receive the Enrollment Rebate until all properly completed reward Claim Documents are received.

The Reward Entities shall have no liability for any reward notification that is lost, intercepted, or not received by a potential recipient for any reason. If any Potential Recipient (i) does not respond within the time required by the Sponsor (including, without limitation, if the reward notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such potential recipient will forfeit his or her Enrollment Rebate.

GRANT OF RIGHTS: By submitting the Rebate Submission Form, each Entrant agrees that the Submission is gratuitous and made without restriction, that it will not place the Sponsor under any obligation other than as stated in these Official Rules, that the Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any

additional compensation to the Entrant. Each Entrant acknowledges that, by acceptance of a Submission, that the Sponsor does do not waive any rights to use similar or related ideas previously known to the Sponsor or developed by its employees or obtained from sources other than the Entrant.

Each Enrollment Rebate Reward Entrant hereby irrevocably grants the Sponsor, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully-paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submissions in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Reward and other promotions. The Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which the Sponsor deems necessary or desirable, and each Entrant irrevocably waives any and all so-called moral rights they may have therein. Entrants further agree: (i) that the Reward Entities may exercise any and all rights hereunder without notification or compensation (except for any prize to be rewarded hereunder); (ii) that the Reward Entities shall have the right to freely assign their rights hereunder, in whole or in part, to any other person or entity, without notification or approval by Entrants; (iii) the Sponsor shall have no obligation (express or implied) to use any Submission or to otherwise exploit any Submission or, if commenced, to continue the distribution or exploitation thereof, and the Sponsor may at any time abandon the use of any Submission for any reason, with or without legal justification or excuse, and Entrants shall not be entitled to any damages or other relief by reason thereof; and (iv) to sign and deliver to the Reward Entities such documents as the Reward Entities may reasonably require to effectuate the rights granted herein. The Sponsor shall not incur any liability whatsoever to the extent the Sponsor chooses to refrain from any exploitation of its rights hereunder.

PRIZES AND APPROXIMATE RETAIL VALUES: The Candidate will receive one (1) \$200 Visa Gift Card Texas Teachers of Tomorrow. To claim the Enrollment Rebate, they must complete the following requirements before October 1, 2021: (i) Take and the required TExES Content Exam and receive a passing score by October 1, 2021; (ii) Secure verifiable teaching employment by October 1, 2021. The Enrollment Rebate will be voided if the Enrollment Rebate Recipient and/or Texas Teachers of Tomorrow cannot verify that they have completed the prescribed requirements.

The Enrollment Rebate does not include any additional monetary funds and cannot be claimed for cash value. No additional or current reward funds will be transferred to additional resources. No extra funds towards the program will be transferred or released.

GENERAL: By entering the Enrollment Rebate, each Entrant agrees to release and hold the Sponsor harmless, and their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, prize suppliers, and each of their respective officers, directors, employees, and agents, and any other person or entity involved in the production, development, implementation or handling of the Enrollment Rebate (collectively, the “Reward Entities”) from and against any claim or cause of action, to the fullest extent permissible by law, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Enrollment Rebate, or receipt or use or misuse of the Enrollment Rebate. The Sponsor assumes no responsibility for any damage to an Entrant's computer system which is occasioned

by participating in the Enrollment Rebate, or for any computer system, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions, or network connections that are human or technical. Without limiting the generality of the foregoing, the Reward Entities are not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, or stolen entries, or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or the incorrect or inaccurate capture of information, or the failure to capture any information. The Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Enrollment Rebate, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Enrollment Rebate, or to annoy, abuse, threaten or harass any other person, and the Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

In the event insufficient eligible Submissions are received, or the Sponsor is prevented from awarding the Enrollment Rebate or continuing with the Enrollment Rebate, as contemplated herein by any event beyond its control, the Sponsor shall have the right to modify, suspend, or terminate the Enrollment Rebate. If the Enrollment Rebate is terminated for any reason before the designated end date, the Sponsor will (if possible) select the potential recipients from all eligible, non-suspect entries received as of the date of the event giving rise to the termination.

The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If by reason of a print or other error, more awards are claimed than the number outlined in these Official Rules, Enrollment Rebate Recipients will be selected in accordance with the Enrollment Rebate selection method described above from among all eligible claimants making purportedly valid claims to the advertised number of Enrollment Rebates.

PUBLICITY RELEASE: Except where legally prohibited, each Enrollment Rebate Recipient consents to the use of his or her name and likeness, photograph, voice, opinions, social media account handle, and city and state of residence in print, broadcast, Internet, and other media for advertising, promotional and/or marketing purposes without additional compensation, limitation, restriction, notice, review or approval.
