*Overview: This offer is only available to currently enrolled candidates who **have** passed a TExES Content Exam prior to April 11, 2021, and who **have not** completed their Pre-Service Requirements in full. To be eligible, candidates must complete all Pre-Service Requirements before June 30, 2021. Additionally, candidates must get hired by December 31, 2021. Reward recipients will be announced between January 1, 2022 – February 28, 2022. Up to 500 gift cards will be released.*

### Official Rules

*The Sponsor of 2021 Teachers of Tomorrow's: Get Ready to Get Paid \$100 Gift Card Reward ("Gift Card Reward") is Teachers of Tomorrow ("Sponsor"). By participating in this Gift Card Reward, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. All federal, state, local laws, and regulations apply. The Sponsor's computer is the official timekeeping device for the Gift Card Reward.*

*No purchase is necessary to enter. Purchases will not increase your chances of receiving the Gift Card Reward. Void where prohibited. The Gift Card Reward may not be redeemed for cash value and cannot be combined with any other discounts, rebates, giveaways, or promotions. The Gift Card Reward is in no way sponsored, endorsed, or administered by, or associated with, other programs. You are NOT eligible to claim this promotion (Get Ready to Get Paid \$100 Gift Card Reward) if you have already received any other discounts, rebates, giveaways, or promotions from Teachers of Tomorrow.*

**GIFT CARD REWARD PROCEDURE:** The Gift Card Reward Procedure will flow as follows:

1. Complete all Texas Teachers Pre-Service Requirements by June 30, 2021.
2. Submit Discount Submission Form by June 30, 2021, located on the official Texas Teachers of Tomorrow webpage.

After the submission and verification period, the Gift Card Reward will be released in accordance with the judging criteria as defined below:

- **Requirement Period:** The Requirement Period for the "Gift Card Reward" begins on April 12, 2021, at 12:00:01 a.m. Central Time ("CT") and ends on June 30, 2021, at 11:59:59 p.m. CT. Candidates must complete all Pre-Service Requirements during the Requirement Period.
- **Submission Period:** The Submission Period for the "Gift Card Reward" begins on April 12, 2021, at 12:00:01 a.m. Central Time ("CT") and ends on June 30, 2021, at 11:59:59 p.m. Candidates must submit the Submission Form before the close of the Submission Period.
- **Verification Period:** The Verification Period will begin in December 2021.
- **Gift Card Reward Recipients Announcement:** The announcement of the Gift Card Reward Recipients be communicated via email between January 1, 2022 – February 28, 2022.

---

**ELIGIBILITY:** Submissions for the Gift Card Reward are open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. Texas Teachers candidates hired prior to April 11, 2021, are NOT eligible. ONLY candidates who are currently enrolled in the Texas Teachers of Tomorrow certification program and HAVE passed their TExES Content Exam prior to April 11, 2021, and HAVE NOT finished their Pre-Service Requirements prior to April 11, 2021, are eligible to receive the Gift Card Reward. Additionally, only candidates who complete all Pre-Service Requirements during the Requirement Period and submit the Submission Form before the close of the Submission Period are eligible to receive the Gift Card Reward. To receive the Gift Card Reward, the candidate must be hired before December 31, 2021.

**HOW TO ENTER:** The candidate may enter for the Gift Card Reward by submitting the Submission Form, including full name, phone number, email address, and date of last module completion, located on the official Texas Teachers of Tomorrow webpage. To be considered for the Gift Card Reward, the candidate must submit the Submission Form before the Submission Period closes. Candidates who successfully complete all Pre-Service Requirements during the Requirement Period and submit the Submission Form before the close of the Submission Period are eligible to receive the Gift Card Reward.

**NUMBER OF ENTRIES:** By taking the aforementioned steps outlined in the Gift Card Reward Procedure, each entrant will receive one (1) entry. Candidates are only eligible to receive one (1) Gift Card Reward. Additionally, if awarded the Gift Card Reward, the candidate is not eligible to receive any additional discounts, rebates, giveaways, or promotions.

**SUBMISSION REQUIREMENTS:** To receive the Gift Card Reward, candidates must complete Pre-Service Requirements during the Requirements Period (June 30, 2021). The following requirements compose Pre-Service Requirements:

- Complete all required Classroom Readiness Training modules located on the “Training Progress” page within your Intern Portal.
- Complete all online training modules and 30 Field Base Experience hours, included in Phase I Training.

Candidates must submit proof of completion by submitting the Submission Form, located on the official Texas Teachers of Tomorrow webpage by the Submission Period (June 30, 2021). The following information must be submitted in the Submission Form:

- First Name
- Last Name
- Phone Number
- Email Address
- Date of Last Completed Module(s)

All submitted forms will be reviewed and verified by Teachers of Tomorrow before any discount is awarded.

#### **ADDITIONAL REQUIREMENTS**

Each Submission must meet the following "Submission Requirements" (and any Submission that, in Sponsor's sole and absolute discretion, violates the following criteria will be disqualified and will not be returned or acknowledge by the Sponsor):

- Submission must be on the Texas Teachers of Tomorrow website;
- Submission must be an entrant who enrolled in the Texas Teachers of Tomorrow Program prior to April 11, 2021;
- Candidate must have already received a passing score on required TExES Content Exam(s) for the corresponding subject area for which they were approved by Texas Teachers of Tomorrow before April 11, 2021.
- Candidate must be hired before December 31, 2021.
- Candidate must not have completed Pre-Service Requirements before April 11, 2021.
- Submissions must be entirely original to the participant;
- Submissions must NOT have been previously submitted to another offer, reward, rebate, or giveaway, that would conflict with this Gift Card Reward, as determined by the Sponsors' sole discretion;
- Submissions must NOT include third parties/people, who have not expressly authorized the entrant to display their image or likeness in the Submission for purposes of this Gift Card Reward. Third Parties include but are not limited to celebrities, friends, and minors who have not obtained parental consent prior to such participation;
- Submissions must NOT contain any personally identifiable information of the entrant unless required (e.g. reasons why they need the Gift Card Reward,);

**VERIFICATION PERIOD:** During the Verification Period, Sponsor will review all Submissions to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements outlined in these Official Rules shall result in a voided submission at the Sponsor's sole discretion. If approved, candidates will be notified by personal message to their email account.

**REWARD RECIPIENT SELECTION:** At the close of the Verification Period, the Submissions will be reviewed by judges based on completion of requirements and verification of Pre-Service Requirements completion. Selections will be deemed as a potential Gift Card Reward recipient.

The potential recipient will be notified by direct message to the email the potential awardee used to submit the Submission entry. The potential recipient must respond to Sponsor's notice within forty-eight (48) hours after the time of notice or else that potential recipient may be disqualified and voided.

The potential recipient may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Gift Card Reward (the "Reward Claim Documents"), within a reasonable amount of time, as determined by the Sponsor in their sole discretion. The potential recipient will not be eligible to receive a gift card reward until all properly completed Reward Claim Documents are received.

The Sponsor shall have no liability for any reward notification that is lost, intercepted, or not received by a potential recipient for any reason. If any potential recipient (i) does not respond within the time required by the Sponsor (including, without limitation, if the reward notification is returned as unclaimed or

undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such potential recipient will forfeit his or her prize and an alternate recipient may be selected based on the selection process outlined in this Section.

**GRANT OF RIGHTS:** By submitting a Submission, each entrant agrees that the Submission is gratuitous and made without restriction, that it will not place the Sponsor under any obligation other than as stated in these Official Rules, that Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a Submission, Sponsor does do not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant.

Each entrant into the Reward hereby irrevocably grants to Sponsor, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully-paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Reward and other promotions. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. **PRIZES AND APPROXIMATE RETAIL VALUES:** If deemed eligible, the participating candidate will receive one \$100 Gift Card from the Sponsor, Texas Teachers of Tomorrow.

The Gift Card Reward does NOT include any additional monetary funds and cannot be claimed for cash value. No additional or current reward funds will be transferred to additional resources. No extra funds toward the program will be transferred or released.

**GENERAL:** By entering the Gift Card Reward, each entrant agrees to release and hold harmless Sponsor, and their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, prize suppliers, and each of their respective officers, directors, employees, and agents, and any other person or entity involved in the production, development, implementation or handling of the Gift Card Reward (collectively, the “Reward Entities”) from and against any claim or cause of action, to the fullest extent permissible by law, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Gift Card Reward, or receipt or use or misuse of the Gift Card Reward. The Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Gift Card Reward, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Gift Card Reward, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

In the event insufficient eligible Submissions are received, or the Sponsor is prevented from awarding the Gift Card Reward or continuing with the Gift Card Reward, as contemplated herein by any event beyond its control, the Sponsor shall have the right to modify, suspend, or terminate the Gift Card Reward. If the Gift Card Reward is terminated for any reason before the designated end date, Sponsor will (if possible) select the potential recipients from all eligible, non-suspect entries received as of the date of the event giving rise to the termination.

The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.
