2021 Texas Teachers of Tomorrow's #NextTexasTeacher Scholarship Overview | One scholarship will be extended to a potential candidate who is not yet enrolled with Texas Teachers of Tomorrow, as of June 1, 2021. Submissions will be accepted from June 1, 2021 – June 30, 2021. Only one scholarship winner will be awarded by Texas Teachers of Tomorrow throughout the United States.

Official Rules

No purchase is necessary to enter or win. Purchases will not increase your chances of winning. Void where prohibited. This scholarship may not be redeemed for cash value and cannot be combined with any other discounts or promotions. This scholarship is in no way sponsored, endorsed, or administered by, or associated with other programs.

The Sponsor of 20201 Texas Teachers of Tomorrow's #NextTexasTeacher Scholarship ("Scholarship") is Teachers of Tomorrow ("Sponsor"). By participating in this Scholarship, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. All federal, state, local laws, and regulations apply. The Sponsor's computer is the official timekeeping device for the Scholarship.

DISCLAIMER: This Scholarship is an Instagram photo contest. It is only open to US residents and is, in no way, endorsed sponsored by, or associated with Instagram. Contest closes at 11:59:59 PM CT on June 30, 2021. Winners will be announced July-August, 2021. Full Terms & Conditions below.

SCHOLARSHIP PROCEDURE. The Scholarship has four requirements:

- 1. Apply to the Texas Teachers of Tomorrow Program.
- 2. Follow @TexasTeachersACP on Instagram
- 3. Post a photo on Instagram of what inspires the entrant to become a teacher
- 4. Tag the photo with the hashtag #NextTexasTeacher

If the entrant successfully completes all the above steps before the scholarship Closing Period (see below), they will be deemed a potential recipient of the Scholarship.

After the submission and verification period, one (1) Scholarship will be released in accordance with the judging criteria as defined below:

- <u>Submission Period</u>: The Scholarship Submission Period opens to the public on June 1, 2021, at 12:00:01 AM Central Time ("CT") and ends on June 30, 2021, at 11:59:59 PM CT.
- <u>Closing Period</u>: The Scholarship Closing Period will begin 1-30 days after the Scholarship Period has closed.
- <u>Winner Announcement:</u> The announcement of the winner will take place in July August 2021.

ELIGIBILITY: Scholarship submission is open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. It is NOT OPEN to currently enrolled candidates in any Teachers of Tomorrow's programs if they enrolled in our program/paid the enrollment fee before June 1, 2021. Paying the enrollment fee is not required to enter but MUST be submitted by the scholarship recipient in order to receive the full program scholarship. The scholarship will cover the full remaining program balance, less the enrollment fee, at the time of enrollment.

HOW TO ENTER: The Scholarship may be entered by applying to the Texas Teachers of Tomorrow Program, following @TexasTeachersACP on Instagram, posting a photo on Instagram of what inspires the entrant to become a teacher, and tagging the posted photo with the hashtag #NextTexasTeacher before the scholarship closing period.

NUMBER OF ENTRIES: By taking the aforementioned steps, an entrant will receive one (1) entry per each photo posted on Instagram; unlimited entries are accepted. Each Submission must meet the following "Submission Requirements" (and any Submission that, in Sponsor's sole and absolute discretion, violates the following criteria will be disqualified and will not be returned or acknowledge by the Sponsor):

- Submission must be on the Texas Teachers of Tomorrow website.
- Submission must apply to Texas Teachers of Tomorrow (ACP).
- Submission must be an entrant who is not enrolled in the Texas Teachers of Tomorrow Program prior to June 1, 2021.
- Entrant must follow @TexasTeachersACP on Instagram.
- Entrant must post a photo on Instagram of what inspires the entrant to become a teacher.
- Entrant must tag the photo with the hashtag #NextTexasTeacher
- Submissions (including photos posted on Insagram) must NOT contain material which is (or
 promoting activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating (e.g.,
 relating to murder, the sales of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex,
 religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking,
 substance abuse, computer hacking, etc.), offensive, inappropriate, threatening, profane, or harassing;
 or material that contains any derogatory references to any Scholarship Entities (as defined below);
- Entrant must adhere to all <u>Terms of Use</u> imposed by Insagram, when using the Instagram platform.
- Submissions must be entirely original to the participant;
- Entrant must have a GPA of 2.5;
- Entrant must be eligible to enroll;
- Submissions must NOT include third parties/people, who have not expressly authorized entrant to display their image or likeness in the Submission for purposes of this Scholarship. Third Parties include but are not limited to celebrities, friends, and minors who have not obtained parental consent before such participation;
- Submissions must NOT contain any personally identifiable information of the entrant (e.g. last name, address, phone number);
- Must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity, or intellectual property rights, or that constitutes copyright, trademark, or patent infringement; and
- Must not contain brand names or trademarks other than those owned by Sponsor, which entrants have a limited license to use to incorporate in entrant's Submission.



VERIFICATION PERIOD: During the Verification Period, Sponsor will review all Submission(s) to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements outlined in these Official Rules shall result in a voided submission at the Sponsor's sole discretion.

WINNER SELECTION: At the close of the Closing Period, the Submission(s) will be reviewed by the judge(s) based on creativity, originality, and completion of requirements. Selection will be deemed a potential scholarship recipient. Regardless of the number of entries, only ONE scholarship will be awarded. The Sponsor will select the winner by reviewing the Instagram tag #NextTexasTeacher on the Instagram platform. Winner will be selected at random and all requirements will be verified before the Scholarship is extended to the potential winner.

The potential winner will be notified either by direct message to the entrant's Instagram account or to the email the potential winner used to submit their Texas Teachers online application. The potential winner must respond to Sponsor's notice within forty-eight (48) hours after the time of notice, or else the potential winner may be disqualified. Should the potential accept the Scholarship, they must submit the Texas Teachers enrollment fee of \$295, or the enrollment fee stated at the official site at the time of enrollment, within seven (7) business days. Should the potential winner fail to submit the enrollment fee within the stated timeframe, the offer becomes void and the Sponsor will select another potential winner. This process will be repeated up to five (5) times until a valid winner is selected.

The potential winner may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Scholarship Entities (the "Prize Claim Documents"), within a reasonable amount of time, as determined by the Scholarship Entities in their sole discretion. The potential winner will not be eligible to receive a scholarship until all properly completed scholarship Claim Documents are received.

The Scholarship Entities shall have no liability for any winner notification that is lost, intercepted, or not received by a potential winner for any reason. If any potential winner (i) does not respond within the time required by the Sponsor (including, without limitation, if the winner notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such potential winner will forfeit his or her prize and an alternate winner may be selected based on the selection process outlined in this Section.

GRANT OF RIGHTS: By submitting a Submission, each entrant agrees that the Submission is gratuitous and made without restriction, that it will not place the Sponsor under any obligation other than as stated in these Official Rules, that Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a Submission, Sponsor does do not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant.

Each entrant into the Scholarship hereby irrevocably grants to Sponsor, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully-paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity



and promotional purposes in connection with the Scholarship and other promotions. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. Entrants further agree: (i) that the Scholarship Entities may exercise any and all rights hereunder without notification or compensation (except for any prize to be scholarship hereunder); (ii) that the Scholarship Entities shall have the right to freely assign their rights hereunder, in whole or in part, to any other person or entity, without notification or approval by entrants; (iii) Sponsor shall have no obligation (express or implied) to use any Submission or to otherwise exploit any Submission or, if commenced, to continue the distribution or exploitation thereof, and Sponsor may at any time abandon the use of any Submission for any reason, with or without legal justification or excuse, and entrants shall not be entitled to any damages or other relief by reason thereof; and (iv) to sign and deliver to the Scholarship Entities such documents as the Scholarship Entities may reasonably require to effectuate the rights granted herein. PRIZES AND APPROXIMATE RETAIL VALUES: The candidate will receive one full program scholarship (excluding the program enrollment fee at the time of enrollment) for Teachers of Tomorrow. They must complete the Teachers of Tomorrow's program to receive a Standard Certificate by January 1, 2025, or the scholarship becomes void. Scholarship will be voided if the award winner is officially discharged/drop by Teachers of Tomorrow.

The scholarship does NOT include the enrollment fee at the time of enrollment. The Sponsor will award the Scholarship which will cover, in full, the remaining program balance of \$4,350/stated program fee at the time of enrollment, 2021, per the website. The scholarship does not include Texas Education Agency Technology Fee (\$35), Certification Exam (\$116 (additional fees may apply)), Background Check/Fingerprinting (\$52.20), Intern Certificate (\$78), PPR Test (\$116), Standard Certificate (\$78) or any other additional fees. No additional or current scholarship funds will be transferred to additional resources. No extra funds towards the enrollment or program will be transferred or released.

GENERAL: By participating in the scholarship, each entrant agrees to release and hold harmless Sponsor, and their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, prize suppliers, and each of their respective officers, directors, employees, and agents, and any other person or entity involved in the production, development, implementation or handling of the scholarship (collectively, the "Scholarship Entities") from and against any claim or cause of action, to the fullest extent permissible by law, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the scholarship, or receipt or use or misuse of any scholarship. Entrants further agree that the scholarship, Entities have not made any warranty, representation or guarantee express or implied, in fact, or law, concerning the scholarship(s), including, without limitation, to such prize's quality or fitness for a particular purpose.

Sponsor assumes no responsibility for any damage to an entrant's computer system which is occasioned by participating in the scholarship, or for any computer system, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions, or network connections that are human or technical. Without limiting the generality of the foregoing, the Scholarship Entities are not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, or stolen entries, or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer,

The Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the scholarship, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Scholarship, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law.

In the event insufficient eligible Submissions are received, or the Sponsor is prevented from awarding scholarship prize(s) or continuing with the scholarship, as contemplated herein by any event beyond its control, the Sponsor shall have the right to modify, suspend, or terminate the scholarship, If the scholarship, is terminated for any reason before the designated end date, Sponsor will (if possible) select the potential winner from all eligible, non-suspect entries received as of the date of the event giving rise to the termination.
