

## Teachers of Tomorrow District Referral

### School District Referral Program

Refer a New Teacher and to receive a \$100 Off!

Submissions will be accepted from Jan 1, 2018 - Dec 30, 2020 for selection, of award discount and would be applied within 30 days of the application date. The submission is up to 1 person per lifetime and will be released by Teachers of Tomorrow throughout the United States.

### Official Rules

NO PURCHASE NECESSARY TO BE AWARDED DISCOUNT. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF BEING AWARDED. VOID WHERE PROHIBITED. THIS DISCOUNT AWARD IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY, OR ASSOCIATED WITH OTHER PROGRAMS.

- 1. DISTRICT REFERRAL DESCRIPTION.** The “Teachers of Tomorrow District Referral Program” (“Discount of \$100”) offers school districts to submit eligible entrants of future teachers to apply to the Teachers of Tomorrow Program to be award a discount. After the submission of the district and the application submission of the future teacher named by the district a verification period of a panel of judges will determine accepting of the eligible submission (as described in more detail below). Up to 1 discount will be awarded in accordance with meeting the criteria as defined below.

The discount award will flow as follows:

- **Submission Period:** The District Referral Period begins on from Jan 1, 2018 at 12:00:01 a.m. Central Time (“CT”) and ends on from Dec 31, 2020, at 11:59:59 p.m. CT.
- **Verification Period:** The District Referral review period will start 24 hours after submission of the application and email to list@teachersoftomorrow.
- **Discount Awarded Announcement:** The announcement of the discount will take place around 30+ days after verification period.

The Teachers of Tomorrow District Referral Discount is Teachers of Tomorrow, By participating in this award, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. All federal, state, and local laws and regulations apply. Sponsor’s computer is the official timekeeping device for this award.

**2. ELIGIBILITY:** Discount submission is open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. You are NOT eligible if you already enrolled into any of the Teachers of Tomorrow certification / licenses programs. The official recommendation must be by a state accredited school and verified before your enrollment. You must apply and email Teachers of Tomorrow to be eligible.

**3. HOW TO ENTER / SUBMISSION REQUIREMENTS:** The "School District Referral Program" (the "School District Referral Discount") must submit an eligible entrant of a future teacher and the future teacher must apply to the Teachers of Tomorrow Program and submit an email to [thelist@stateteacher.org](mailto:thelist@stateteacher.org). By taking these steps, an entrant will receive one (1) entry into the School District Referral Program. Each Submission must meet the following "Submission Requirements" (and any Submission that, in Sponsor's sole and absolute discretion, violates the following criteria will be disqualified):

- Submission must be on the Teachers of Tomorrow website
- Accredited School with a district email must submit a New Teacher Referral Form
- Submission must apply any Teachers of Tomorrow (ACP ALP)
- Submission must become a teacher by Aug 15, 2023
- Submission must apply to Teachers of Tomorrow website
- Submission must email [thelist@stateteacher.org](mailto:thelist@stateteacher.org) after applying with First Name, Last Name, Phone, Email and include a subject line of Teachers of Tomorrow District Referral
- Submissions must NOT contain material which is (or promoting activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking, substance abuse, computer hacking, etc.), offensive, inappropriate, threatening, profane, or harassing; or material that contains any derogatory references to any discount (as defined below);
- Submissions must be entirely original to the participant;
- Submissions must NOT have been previously submitted to another discount or submitted to any entity that would conflict with this discount, as determined in the discount Entities' sole discretion;
- Submissions must NOT include third parties/people, who have not expressly authorized entrant to display their image or likeness in the Submission for purposes of this discount. Third Parties include but are not

limited to celebrities, friends and minors who have not obtained parental consent prior to such participation;

- Submissions must NOT contain any personally identifiable information of the entrant unless required (e.g. reasons why the need the discount,); and
- Must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright, trademark or patent infringement.

**Limit one (1) submissions per person, regardless of method of submission**

Any attempt by any submission to obtain more than one (1) submission per person by using multiple/different e-mail addresses, identities or any other methods will void that entrant's entries and that entrant will be disqualified. Submissions will not be returned or acknowledged by the discount

**4. VERIFICATION PERIOD:** During the Verification Period, Sponsor will review all Submissions to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements set forth in these Official Rules shall result in a voided submission in Sponsor's sole discretion.

**5. AWARDED DISCOUNT SELECTION:**

(A) 2019 Teachers of Tomorrow District Referral: At the close of the **VERIFICATION PERIOD**, the Submission will be reviewed by judge's based on (originality) and completion of requirements. Selection will be deemed the potential discount.

The potential discount will be notified by direct message to the email the submission used to submit the Submission entry. The potential discount must respond to Sponsor's notice by Dec 31, 2020 after the time of notice or else that potential awardee/ discount may be disqualified. The potential awardee may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Teachers of Tomorrow District Referral Entities (the "Discount Claim Documents"), within a reasonable amount of time, as determined by the Discount Entities in their sole discretion. The potential award will not be eligible to

receive a discount until all properly completed discount Claim Documents are received.

The Discount Entities shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If any potential winner (i) does not respond within the time required by Sponsor (including, without limitation, if the winner notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason, such potential winner will forfeit his or her prize and an alternate winner may be selected based on the selection process set forth in Section.

**6. GRANT OF RIGHTS:** By submitting a Submission, each entrant agrees that the Submission is gratuitous and made without restriction, that it will not place Sponsor under any obligation other than as stated in these Official Rules, that Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a Submission, Sponsor does not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant.

Each entrant into the Discount hereby irrevocably grants to Sponsor, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Discount and other promotions. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all so-called moral rights they may have therein. They must complete the teachers of tomorrow program / receive standard certificate / License by **Aug 015, 2023** or the discount becomes **void**. Discount will become **void** if submission was not recommended by an accredited state school. Teachers of Tomorrow Discount will be **voided** if the award discount is official discharged / drop by Teachers of Tomorrow. The discount only includes the \$100 off the enrollment and will be applied to the final cost. The discount does not include Texas Education Agency Technology Fee @ \$35, Certification Exam @ \$116 (additional fees may apply), Background Check / Fingerprinting @ \$52.20, Intern Certificate @ \$78, PPR Test @ \$116, Standard Certificate @ \$78. No additional or current discount funds will be transferred to additional resources.

**8.
