2019 Teachers of Tomorrow Annual Full Scholarship

Submissions will be accepted from October 1-31 for selection, scholarship winners will be announced in the month of November or December. One winner per school. Up to 20 scholarships will be released by Teachers of Tomorrow throughout the United States.

# **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. THIS SCHOLARSHIP IS IN NO WAY SPONSORED, ENDORSED, OR ADMINISTERED BY, OR ASSOCIATED WITH.

**1. SCHOLARSHIP DESCRIPTION**. The "2019 Teachers of Tomorrow Annual Full Scholarship" ("scholarship") offers eligible entrants the opportunity to submit a message "Why do you want to be a teacher?" and apply to the Teachers of Tomorrow Program. After the submission and verification period (as described in more detail below), up to 20 scholarships will be released in accordance with the judging criteria as defined below.

The Scholarship will flow as follows:

- **Submission Period**: The Scholarship Submission Period begins on October 1, 2019, at 12:00:01 a.m. Central Time ("CT") and ends on October 31, 2019, at 11:59:59 p.m. CT.
- Verification Period: The Scholarship Judging Period will be in November.
- Winner Announcement: The announcement of the winner will take place around November or December.

The Sponsor of this Scholarship is Teachers of Tomorrow, By participating in this Scholarship, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. All federal, state and local laws and regulations apply. Sponsor's computer is the official timekeeping device for this Scholarship.

**2. ELIGIBILITY**: ELIGIBILITY: Scholarship submission is open only to legal U.S. residents residing in the fifty (50) United States and District of Columbia. It is NOT OPEN to current enrolled interns in all Teachers of Tomorrows programs if they enrolled in our program / paid the enrollment fee before October 1, 2019. Paying the enrollment fee after October 1, 2019 is not required to enter.

**3. HOW TO ENTER**: The "2019 Teachers of Tomorrow Annual Full Scholarship" (the " Scholarship offers eligible entrants the opportunity to submit a message of "Why do you want to be a teacher?" and apply to the Teachers of Tomorrow Program. By taking these steps, an entrant will receive one (1) entry into the scholarship. Each Submission must meet the following "Submission Requirements" (and any Submission that, in Sponsor's sole and absolute discretion, violates the following criteria will be disqualified):

- Submission must be on the Teachers of Tomorrow website
- Submission must apply to Teachers of Tomorrow (ACP)
- Submission must be a substitute teacher or Para Educator / Paraprofessional or willing to become a bilingual teacher by Aug 01, 2021.\*
- Submission should reflect why you want to become a teacher
- Submissions must NOT contain material which is (or promoting activities which are) sexually explicit, obscene, pornographic, violent, self-mutilating (e.g., relating to murder, the sales of weapons, cruelty, abuse, etc.), discriminatory (based on race, sex, religion, natural origin, physical disability, sexual orientation or age), illegal (e.g. underage drinking, substance abuse, computer hacking, etc.), offensive, inappropriate, threatening, profane, or harassing; or material that contains any derogatory references to any Scholarship Entities (as defined below);
- Submissions must be entirely original to the participant;
- Submission must have a GPA of 2.5
- Submissions must NOT have been previously submitted to another Scholarship or submitted to any entity that would conflict with this Scholarship, as determined in the Scholarship Entities' sole discretion;
- Submissions must NOT include third parties/people, who have not expressly authorized entrant to display their image or likeness in the Submission for purposes of this Scholarship. Third Parties include but are not limited to celebrities, friends, and minors who have not obtained parental consent before such participation;
- Submissions must NOT contain any personally identifiable information of the entrant (e.g. last name, address, phone number); and
- Must not contain material that violates or infringes another's rights, including but not limited to privacy, publicity or intellectual property rights, or that constitutes copyright, trademark or patent infringement.
- Must not contain brand names or trademarks other than those owned by Sponsor, which entrants have a limited license to use to incorporate in entrant's Submission.

**Limit one (1) submissions per person, regardless of method of submission** Any attempt by any submission to obtain more than one (1) submission per person by using multiple/different e-mail addresses, identities or any other methods will void that entrant's entries and that entrant will be disqualified. Submissions will not be returned or acknowledged by the Scholarship

**4. VERIFICATION PERIOD**: During the Verification Period, Sponsor will review all Submissions to determine eligibility under these Official Rules, including, without limitation, compliance with the Submission Requirements. Failure to comply with the requirements outlined in these Official Rules shall result in a voided submission in the Sponsor's sole discretion.

### **5. WINNER SELECTION:**

(A) 2019 Teachers of Tomorrow Annual Full Scholarship: At the close of the **VERIFICATION PERIOD**, the Submission will be reviewed by the judge based on (creativity and originality) and completion of requirements. Selection will be deemed a potential scholarship.

The potential winner will be notified by direct message to the email the potential winner used to submit the Submission entry. The potential winner must respond to Sponsor's notice within forty-eight (48) hours after the time of notice or else that potential winner may be disqualified. The potential winner may be required to execute and return an affidavit of eligibility, a liability release and, unless prohibited by law, a publicity release and other related documents required by the Scholarship Entities (the "Prize Claim Documents"), within a reasonable amount of time, as determined by the Scholarship Entities in their sole discretion. The potential winner will not be eligible to receive a scholarship until all properly completed scholarship Claim Documents are received.

The scholarship Entities shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If any potential winner (i) does not respond within the time required by Sponsor (including, without limitation, if the winner notification is returned as unclaimed or undeliverable), (ii) is found to be ineligible, (iii) has not complied with these Official Rules, or (iv) declines the prize for any reason , such potential winner will forfeit his or her prize and an alternate winner may be selected based on the selection process set forth in Section.

**6. GRANT OF RIGHTS**: By submitting a Submission, each entrant agrees that the Submission is gratuitous and made without restriction, that it will not place Sponsor under any obligation other than as stated in these Official Rules, that Sponsor is free to publish or otherwise disclose the ideas contained in the Submission on a non-confidential basis to anyone or otherwise use the ideas without any additional compensation to the entrant. Each entrant acknowledges that, by acceptance of a Submission, Sponsor does do not waive any rights to use similar or related ideas previously known to Sponsor or developed by its employees or obtained from sources other than entrant.

Each entrant into the Scholarship hereby irrevocably grants to Sponsor, its designees, affiliates, successors and assigns, the exclusive, irrevocable, fully-paid, universal license to use, copy, sublicense, transmit, distribute, publicly perform, publish, delete or display the Submission in any media now known or hereafter devised including, but not limited to all forms of electronic media, social media, print media and all forms of internet and wireless protocol in perpetuity and throughout the universe for advertising, marketing, publicity and promotional purposes in connection with the Scholarship and other promotions. Sponsor shall have the right, in its sole discretion, to edit, composite, morph, scan, duplicate, or alter the Submission for any purpose which Sponsor deems necessary or desirable, and each entrant irrevocably waives any and all socalled moral rights they may have therein. Entrants further agree: (i) that the Scholarship Entities may exercise any and all rights hereunder without notification or compensation (except for any prize to be scholarship hereunder); (ii) that the Scholarship Entities shall have the right to freely assign their rights hereunder, in whole or in part, to any other person or entity, without notification or approval by entrants; (iii) Sponsor shall have no obligation (express or implied) to use any Submission, or to otherwise exploit any Submission or, if commenced, to continue the distribution or exploitation thereof, and Sponsor may at any time abandon the use of any Submission for any reason, with or without legal justification or excuse, and entrants shall not be entitled to any damages or other relief by reason thereof; and (iv) to sign and deliver to the

Scholarship Entities such documents as the Scholarship Entities may reasonably require to effectuate the rights granted herein. The sponsor shall not incur any liability whatsoever to the extent the Sponsor chooses to refrain from any exploitation of its rights hereunder.

#### 7. PRIZES AND APPROXIMATE RETAIL VALUES:

(A) Scholarship Winner / Scholarship

Scholarship Winner containing:

The candidate will receive one full scholarship for Teachers of Tomorrow. They must complete the teachers of tomorrow's program to receive a standard certificate by **Aug 01, 2021** or the scholarship becomes **void**. The scholarship will become **void** if the submission was not by the substitute teacher or Para Educator / Paraprofessional awarded or did not become a bilingual teacher by **Aug 01, 2021**. Teachers of Tomorrow Scholarship will be **voided** if the award winner is officially discharged/drop by Teachers of Tomorrow. The scholarship only includes the \$395 enrollment fee and the program balance of \$4,350 / stated program fee of **Oct 1, 2019** per the website. The scholarship does not include Texas Education Agency Technology Fee @ \$35, Certification Exam @ \$116 (additional fees may apply), Background Check / Fingerprinting @ \$52.20, Intern Certificate @ \$78, PPR Test @

\$116, Standard Certificate @ \$78 or any other additional fees. No additional or current scholarship funds will be transferred to additional resources. No extra funds towards the enrollment or program will be transferred or released.

**8.** GENERAL: By participating in the scholarship, each entrant agrees to release and hold harmless Sponsor, and their respective parent companies, subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, prize suppliers, and each of their respective officers, directors, employees and agents, and any other person or entity involved in the production, development, implementation or handling of the scholarship (collectively, the "Scholarship Entities") from and against any claim or cause of action, to the fullest extent permissible by law, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the scholarship, or receipt or use or misuse of any scholarship. Entrants further agree that the scholarship, Entities have not made any warranty, representation or guarantee express or implied, in fact, or law, concerning the scholarship(s), including, without limitation, to such prize's quality or fitness for a particular purpose. Sponsor assumes no responsibility for any damage to an entrant's computer system which is occasioned by participating in the scholarship,, or for any computer system, hardware, software or program malfunctions, or other errors, failures, delayed computer transmissions or network connections that are human or technical. Without limiting the generality of the foregoing, the Scholarship Entities are not responsible for incomplete, illegible, misdirected, misprinted, late, lost, damaged, or stolen entries, or prize notifications; or for lost, interrupted, inaccessible or unavailable networks, servers, satellites, Internet Service Providers, websites, or other connections; or for miscommunications, failed, jumbled, scrambled, delayed, or misdirected computer, telephone or cable transmissions; or for any technical malfunctions, failures, difficulties or other errors of any kind or nature; or for the incorrect or inaccurate capture of information, or the failure to capture any information. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the scholarship, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Scholarship, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. In the event an

insufficient number of eligible Submission is received, or Sponsor is prevented from scholarship prize(s) or continuing with the scholarship, as contemplated herein by any event beyond its control, Sponsor shall have the right to modify, suspend, or terminate the scholarship, If the scholarship, is terminated for any reason before the designated end date, Sponsor will (if possible) select the potential winner from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. If any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. If by reason of a print or other error, more awards are claimed than the number outlined in these Official Rules, a winner will be selected in accordance with the winner selection method described above from among all eligible claimants making purportedly valid claims to scholarship the advertised number of awards available.

**9. PUBLICITY RELEASE**: Except where legally prohibited, each winner consents to the use of his/her name and likeness, photograph, voice, opinions, social media account handle and city and state of residence in print, broadcast, Internet and other media for advertising, promotional and/or marketing purposes without additional compensation, limitation, restriction, notice, review or approval.
